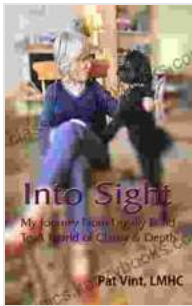


# My Journey From Legally Blind To World Of Clarity & Depth

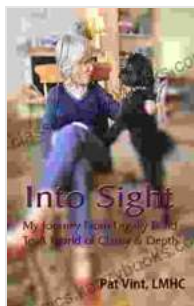

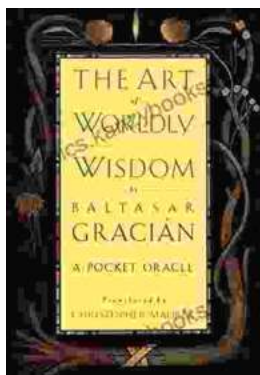
